Procedure for calculation of the placement completion date:

The Fifteenth (15th) day from the completion date of the period for submission of the offers for purchase of additional shares under public placement, as specified in Clause 8.3 of the Resolution as to the Additional Securities Issue, shall be the securities placement completion date.

The distribution period cannot be longer than one year since the date of state registration of additional issuing securities issue. The securities placement period shall be determined by indication to the dates of disclosure of any information on the securities issue.

2.10. Actual registration (lack of registration) of the securities prospectus, simultaneously with the state registration of the issue (additional issue) of these securities: the securities prospectus is registered simultaneously with the state registration of the additional issue of these securities.

2.11. In case of registration of the securities prospectus, the procedure for providing access to the information contained in the securities prospectus:
